## Data thieves' #1 targets are small businesses with 100 employees or less.

Data thieves are targeting small business owners in many ways, often using them as a gateway to larger businesses, which puts your company at a higher risk.

### Employees are the #1 cause of data breaches.

Employees are the primary cause of data breaches through either careless or malicious acts. Phishing attacks have increased 1300% in the past two years and ransom attacks are up from 1,000 to 4,000 per day. Employee data security training is often a legal requirement and always a prudent business practice.

## The cost of a security breach is always higher than the cost of protection.

Have you evaluated the cost of data breach protection vs. the cost of having a data breach? Lack of compliant preparation and response can result in:
